Hello SCCAI members. Many of us have gone through the "quiet before the storm" periods in the appraisal industry awaiting our lending clients to figure out their best paths forward during uncertain economies. It just feels to me that the dam is about to break and we're all going to be swamped! As appraisal professionals, I would suggest taking these final days to get Continuing Education or Candidate Education behind you. As always, the Course Listings are here. While you are on the SCCAI website, find a Job Board and other Chapter information. Several classes are on offer for the remainder of this year, as well as the Heritage Dinner in mid-October.

The Education Committee along with others serving the Chapter are making efforts to understand what classes are best to offer our members. We are coordinating with the San Diego Chapter to best offer the Candidate Education requirements without overlap. Furthermore, we are identifying the best locations to hold classroom education throughout the region.

The SCCAI Chapter in years past had several venues that did not charge a fee, but in the last few years those venues are no longer, and thus, we are paying for venues that charge a relatively significant fee to hold classroom education. If anyone in our Chapter is part of a company or community organization that has space to offer free or at a low fee, we would be grateful if you could reach out to Lianna at the SCCAI office.

Again, SCCAI wants to provide classroom education that fits your needs. There are courses available through National AI via synchronous or online; we are not looking to compete. We need to identify the courses best to offer in a classroom setting. We are also striving to provide webinars and networking opportunities throughout the region. With many working from home, we are striving to find beneficial reasons to attend our events and see others face-to-face. There are strange things that appraisers talk about – so we are trying to give spouses, other family, and friends a break!

Lastly, for the Chapter's Mason-Thornton Scholarship Program, we have made some updates to the application process in parallel with some changes at the National Al office. We have added Practicing Affiliates to the list of eligible appraisers to apply. Please note that we are also enforcing the rule to apply at a minimum 30 days prior to a class start date. The eligible education offerings are listed in the application document, which can be found on the Chapter's website.

We would also encourage those who are passionate about helping our younger generation, You can also reach out to the Chapter office how you can contribute to the scholarship Trust Fund, which is a 501(c)(3) non-profit organization.

August is normally a slow month, but this August the Eastern Branch was busy planning and hosting a presentation at the historic Wrigley Mansion on Orange Grove Boulevard in Pasadena. The Mansion is an elegant home which serves as the Tournament of Roses headquarters. It was altogether fitting that the focus of this event was appraising historic homes. Charles Baker, SRA, Al-RRS, gave a thoughtful and very well illustrated presentation called "Notable Residential Landmarks." Charles had photographs and floorplans of many historic and architecturally significant homes, including ones designed by Frank Lloyd Wright, Wallace Neff, and Charles & Henry Greene (Greene and Greene).

Charles showed a map of Pasadena showing areas with historic homes. While Pasadena is a relatively small city it is rich in history with many architecturally significant homes. Los Angeles has several areas designated as "Historic Preservation Overlay Zone.' Charles presented a map of these areas and then described some of the homes in these zones. People who attended the seminar were impressed by the way Charles combined considerations of aesthetics and design with practical insights on valuing unusual properties.

A special thanks to Chapter President Linda Whittlesey and her husband Gregg who truly went the extra mile to make this event happen. Linda and Gregg cleaned up the place after the event so the Chapter would not have to pay the \$500 cleaning fee the Tournament normally charges when the facility is used for an event. This included getting their hands dirty in the mansion kitchen scrubbing the chaffers and loading the dishwasher. This helped keep the cost down. Thanks, Linda and Gregg! (By the way, a chaffer is a dish used for food service, especially in group settings). Also, thanks to Lianna for putting together all the details to ensure that Chapter members could get CE credit for this wonderful event!
